Objective

Identify the parents of James G. Parks, of Stokes County, NC and Houston County, GA.

According to Muscogiana Journal of the Muscogee Genealogical Soceity, Vol 1, No 2, no date:

- James G. Parks married Elizabeth Biggers Woolfolk, marriage bond dated 25 July, 1821 in Stokes County, NC.
- On 4 September, 1830, in Houston County, GA, John Fletcher filed as administrator of James G. Parks' estate.
- In 1830 in Houston County, GA, Elizabeth Parks was head of household with 1 male < 5, 1 female < 5, 1 female 5-10, 2 males 20-30, one male 30-40, and one female 30-40.
- On 29 December, 1826, Sowell Woolfolk sold land to James G. Parks of NC (Houston County, GA Deed Book D, page 363). By 1830, most of Parks property was being mortgaged, requesting that he and his family be supported for a year.
- Sowell Woolfolk (ca 1790 -1832) was an early resident of Muscogee County, GA. He moved to Columbus, GA and married Sophia W. Thomas on 20 December, 1829.
- Sarah Dalton Woolfolk married John P. Parks in 1822 in Stokes County, NC. John P. Parks died on 10 March, 1827 in NC or GA. They had one child, Richard M. Parks, born 1825 in NC.
- Sarah Woolfolk Parks married Col. Philip H. Alston in Columbus, GA on 27 July, 1828. They moved to Clarkesville, Habersham County, GA where Philip H. Alston died in 1832. Note that this is a northeast movement.
- Sarah Woolfolk Alston married Hezekiah Dyer (1799 ca 1860) in Habersham County, GA on 25 December, 1832.
- Sarah Woolfolk Dyer died 2 February, 1860 in Clarkesville, Habersham County, GA.
- Hezekiah Dyer was named guardian of Mary Henrietta Parks, orphan of James G. Parks, on 7 November, 1836. Mary Henrietta Parks was born in NC in 1822. She married John Harris Wyly in 1841. She died 23 November 1894 in Atlanta, GA.
- Camilla C. Parks and James S. Parks, children of James G. Parks and Elizabeth Woolfolk, both lived in Muscogee County, GA or Marion County, GA.

YDNA testing indicates a connection to the Rev. James Parks family of Culpepper County, VA and Surry County, NC.

Summary of findings

In July, 1821 James G. Parks married Elizabeth B. Woolfolk in Stokes County, NC. No other records were found for James G. Parks in Stokes County. In fact, James G. Parks owned land on the western side of Surry County, NC while Stokes County was on the eastern border. However, other records leave no doubt that this is the same James G. Parks.

James G. Parks was taxable in Surry County, NC in 1822. The taxable age in NC at this time was 21. We can estimate James G. Parks was born prior to 1802. James G. Parks owned 75 acres in Jonesville District on Fall Creek next to James Fletcher. He also had 1 slave.

In 1823, James G. Parks served on a jury in Surry County, NC with John P. Parks, James Parks, and James Fletcher among others.

In 1824, James G. Parks was taxed for 100 acres in Jonesville District on Fall Creek, Surry County, NC bordering the widow Fletcher.

In February, 1826, in Surry County, NC, administration of the estate of James Parks, deceased, was granted to John P. Parks who had James G. Parks and Samuel Edwards as his security.

In December, 1826, James G. Parks of NC purchased 202.5 acres in Houston County, GA from Sowell Woolfolk. Sowell Woolfolk of Augusta, GA had purchased the lot in May, 1826.

James G. Parks originally moved to Macon, Bibb County, GA. He had unclaimed letters remaining in the post office there. Houston County, GA was south of Bibb.

James G. Parks owned another lot in Houston County, GA which he sold in January, 1829. It is unclear how he obtained the land.

In April, 1830, James G. Parks was indebted to Wesley Williams for \$450. However, Wesley Williams was acting as power of attorney on behalf of James G. Parks to recover debts owed to him for merchandise sold from his store. It appears that James G. Parks owned a store and was selling goods on credit.

In April, 1830, James G. Parks was indebted to John Fletcher of Jones County, GA for \$4,810. James G. Parks had an open account for goods and merchandise sold to him by John Fletcher probably for the purpose of stocking his store. John Fletcher had also lent money to James G. Parks. James G. Parks mortgaged all of his property to John Fletcher. James G. Parks and his family were to be supported by profits and income from the property but it was stated that James G. Parks could not manage any of the property.

By July, 1830, James G. Parks was deceased. John Fletcher was granted administration of the estate to collect all debts.

The relationship of John Fletcher to James Fletcher is not clear. Note that James G. Parks was a neighbor of James Fletcher in 1822 and "the widow Fletcher" in 1824 in Surry County, NC. There is a will

for James Fletcher dated 1824 in Surry County, NC, but it appears he did not have children. His brother William Fletcher and wife Mary Ann Fletcher were named. Was he the same James Fletcher who married Mary Ann Jones in 1819?

John P. Parks owned lots in the town of Jonesville, Surry County, NC and land adjacent his father James Parks (elder). He was of taxable age in 1818. He owned a store in Jonesville in 1819. In 1823, John P. Parks and Richard H. Parks witnessed a deed for James Parks (elder).

No evidence has been found to confirm that John P. Parks married Sarah Dalton Woolfolk.

In 1824, John P. Parks was heavily indebted in the amount of \$3,914.22. Almost all of his property was secured against the debt. The last records found for him were the 1826 settlement of the James Parks (elder) estate.

An 1832 Surry County, NC deed named all heirs of James Parks (elder), deceased. The heirs were Elizabeth Parks, widow, Richard H. Parks, William J. Parks, John P. Parks, deceased, James Parks, deceased, Martin P. Parks, Gabriel B. Parks, Wiley Parks, Dabney Parks, and Sarah Ann Parks. The heir, James Parks, deceased, was not specially named as James G. Parks, but there is no doubt this was him.

James Parks (elder) owned land on Beach Creek, Hunting Creek, Spencer Creek, Fall Creek, Cobs Creek and lots in Jonesville in Surry County, NC. Like James G. Parks, he was also a neighbor of James Fletcher. James Parks (elder) owned a store with his brother-in-law, Daniel Hunt, in Jonesville.

James Parks (elder) married Elizabeth Jones, daughter of Hardy Jones whose will was written in Surry County, NC in 1819. James Parks and Daniel Hunt were executors of Hardy Jones will.

The evidence is clear that James G. Parks was the son of James Parks and Elizabeth Jones.

- Son William S. Jones to have 5 shillings in addition to what he has already had
- Son Alexander Jones to have:
 - boy slave Squire
 - o the land purchased from William Craft near Jonesville
 - o a lot in Jonesville adjacent John P. Parks
 - o half my interest in the funds of Yadkin Navigation
 - o a bed and furniture when he calls for it
 - o \$200 when my youngest son Samuel comes of age
 - A stud horse
- Wife Mary Ann Jones to have:
 - slave named Patrick
 - slave named Cathe
 - o slave girl named Hester
 - \$200 annually to school, board, and clothe my 4 little children until they come of age
 - Have the use of my house and plantation bought of Allen Sink and 10 acres bought from William Martin, with reversion to my youngest son Samuel
- Son Samuel Jones to receive the other half of my Yakin Navigation funds and \$100
- Three little daughters Janet Jones, Lucretia Jones, and Ann Jones to have \$600 each

The author of <u>Surry County</u>, <u>NC Wills</u>, <u>1771-1827</u>, Jo White Linn, also a professional genealogist, gave the following note following the abstract of the will of Hardy Jones:

- There are loose estate papers at the NC Archives for Hardy Jones dated 1819
- According to DAR records, Hardy Jones was born about 1746 in Lunenburg County, VA and died 21 June, 1819 in Surry County, NC.

On 25 July, 1821, James G. Parks filed a bond to marry Elizabeth B. Woolfolk in Stokes County, NC. Fellow bondsman was Jouse(?) Jarrett. James G. Parks signed his name. [NC Marriage Records, 1741-2011, Stokes, Marriage Bonds (1791-1869), ancestry.com]

In 1822, James G. Parks was taxed for 75 acres in Jonesville District, Surry County, NC. He owned land on Fall Creek adjacent James Fletcher, valued at \$250. He had 1 black poll. [Surry County, NC Original Tax List 1822, Harvey]

On 16 May, 1823, James Parks signed a deed of trust to Davis Durrett (Surry County, NC Book S, Page 55). "Thomas W. Mitchell conveyed in trust to James Parks and Rice Garland a tract of land to secure the payment of a debt to Archibald Robertson and Company of Lynchburg, VA, conditions of which deed of trust are not being complied with by the said Thomas W. Mitchell." "I, James Parks, trustee did advertise and sell the said land according to the conditions of said deed of trust and August Sheppard, agent for said company, did lay off a house and lot in the town of Jonesville, number 34, it being the house and lot where said Mitchell formerly kept store and also the River tract of land containing 300 acres." The land bordered the Yakin River, Cobbs Creek, William Cook, David Cook, Fletcher, A. Downey, and Hampton. James Parks singed his name. Richard N. Parks and John P. Parks witnessed. On 12 November, 1823, it was ordered by the Surry County, NC court "that Daniel Hunt, Ritchard Guin, James Fletcher, James G. Parks, Sam Edwards, William Edwards, Daniel Dejarnett, Benjamin Neilor, John Spener, John P. Parks, Jesse Kouse, and James Parks be appointed a jury if they think proper to turn the road leading from Jonesville to Rockford beginning at Jonesville and proceeding to the Island Ford Meeting House and make report thereof to next court". [Surry County, NC Court Minutes, 1820-1823, Volume 7, Harvey]

In 1824, James G. Parks was taxed for 100 acres in Jonesville District, Surry County, NC. The land was on Fall Creek, bordered the widow Fletcher, and was valued at \$400. He had 1 white poll and 1 black poll. [Surry County, NC Original Tax Lists, 1823, 1824, 1825, Harvey]

On 8 March, 1824, **John P. Parks** signed a deed of trust to John Wright and Peter Clingman (Surry County, NC Book R, Page 295). The deed was to cover debts owed by **John P. Parks**. The debts were described as follows:

- "The condition of the above deeds and conveyances are in trust to secure to Lynch and Cother
 of Petersburg VA the payment of the sum of \$1945.18 with interest thereon from the 5th day of
 March, 1823 due by bond."
- "Also to secure to Joseph Caldwell surviving partner of the firm of Caldwell and Orr the payment
 of the sum of \$1823.83 with interest thereon from 25 June, 1821 due by bond to Caldwell and
 Orr."
- "Also the further sum of \$15.73 due to the firm of Caldwell and Orr by open amount."
- "Also to secure to Bragg and Jones the payment of \$129.48 with interest thereon from 27 June, 1821 due by bond."

The following property was secured in the trust:

- 250 acres on Beaver Dam Creek bordering Willie Craft, Jonathan Sparks, Benjamin Sparks, and Sebastian's line
- 99.75 acres on the waters of Yadkin River bordering Young's corner, the public road, Hampton's line, and the Wilke's County line.
- 63 acres bordering Joseph Sparks line, Jenkin's line, and Lester's line.
- Lot number 38 in the town of Jonesville containing the dwelling and store house of said John P.
 Parks
- Lot number 16 in the town of Jonesville
- Female slave named Tele, age 14
- Female slave named Anne, age 8
- Female slave named Malinda, age 5
- 2 horses
- 1 cow
- All household and kitchen furniture
- Present stock of goods
- All debts and accounts of whatsoever nature now due or owing to me

John P. Parks had until 5 March, 1824 to pay the debts. Otherwise, John Wright and Peter Clingman would put all property up for auction. Witnesses were H.P. Poindexter and Thomas B. Wright. *[Surry County, NC Register of Deeds online,*

On 16 February, 1825, in the Surry County, NC court, in the case of "Raleigh Poe vs. John Bailey", James G. Parks, a witness for Raleigh Poe, proved 3 days and 23 miles. [Surry County, NC Court Minutes, 1824-1828, Volume 8, Harvey]

On 14 February, 1826, "administration on the estate of **James Parkes**, deceased, was granted to **John P. Parkes** who entered into bond in the sum of \$600 with **James G. Parkes** and Samuel Edwards his security and qualified according to law". [Surry County, NC Court Minutes, 1824-1828, Volume 8, Harvey]

On 1 April, 1826, "agreeable to an order of court", T. Hampton, Benjamin Naylor, and Samuel Edwards met at the house of **James Parks**, deceased, to lay off one year's provision for his widow **Elizabeth Parks**. [NC Estate Files, 1663-1979, Surry County, NC, familysearch.org]

Inventory of James Parks

On 17 August, 1826, the case of "David Baker vs. William Warren" was brought before the Surry, County, NC court. The jury sworn in included James G. - One due bill on Henry Richardson for 75 cents without sale
- Received \$15 of John Wright, esquire, as security of Lewis Tankery in part pay of the fees due to said deceased in the account of Tankery and McC_s, administrators

On 29 December, 1826, Sorwell Woolfolk sold lot number 203 in the 15th district of Houston County, GA to James G. Parks of NC for \$500 (Houston County, GA Deed Book D, Page 356). The land was 202.5 acres. Sowell Woolfold signed his name. Frederic Randall and William L. Stapler witnessed. The deed was recorded 7 June, 1830. [Land Records of Houston County, GA, 1829-1831, Deed Book D, Volume 2, Campbell]

Sowell Woolfolk of Augusta, GA had previously purchased lot number 203 in the 15th district of Houston County, GA from Patience Anderson on 18 May, 1826 (Houston County, GA Deed Book D, Page 363). Samuel Williams and John Stapler witnessed. [Land Records of Houston County, GA, 1829-1831, Deed Book D, Volume 2, Campbell]

On 1 April, 1827, James G. Parks was named on a list of unclaimed letters remaining in the post office at Macon, Bibb County, GA. [Macon, GA Newspaper Clippings (Messenger), Volume 1, 1823-1830, Evans]

Note: Bibb County, GA was on the northeastern border of Houston County, GA.

On 21 January, 1829, James G. Parks sold lot number 58 in the 15th District of Houston County, GA, 202.5 acres, to William Snell for \$300 (Houston County, GA Deed Book F, Page 158). The land had originally been drawn by John Brandon of Richmond County, GA on 21 March, 1827. James G. Parks signed his name. Irey T. Hobbs and Thomas Everitt witnessed. The deed was recorded 8 November, 1834. [Land Records of Houston County, GA, 1834-1836, Deed Book F, Volume 2, Campbell]

On 1 January, 1830, James G. Park was named on a list of unclaimed letters remaining in the post office at Macon, Bibb County, GA. [Macon, GA Newspaper Clippings (Messenger), Volume 1, 1823-1830, Evans]

On 27 April, 1830, James G. Parks signed a promissory note to Wesley Williams (Houston County, GA, Deed Book D, Page 388). He was indebted to Wesley Williams for \$450. James G. Parks offered several store accounts as payment. These were debts owed to James G. Parks for goods, wares, and merchandise that he had sold from his store. Wesley Williams was granted power of attorney to collect the debts. Any remaining money was to revert to James G. Parks. William Mizell witnessed. [Land Records of Houston County, GA, 1829-1831, Deed Book D, Volume 2, Campbell]

On 27 April, 1830, James G. Parks signed a promissory note to John Fletcher of Jones County, GA (Houston County, GA, Deed Book D, Page 390). James G. Parks had an open account for goods, wares, and merchandise sold to him by John Fletcher. John Fletcher had also lent money to James G. Parks. James G. Parks owed:

- \$2,160 due by 25 December, 1830
- \$2,150 due by 25 December, 1831
- \$500

James G. Parks mortgaged the following goods to John Fletcher:

- Lot number 203 in the 15th District of Houston County, GA
- Together with all the growing crop of corn, cotton and sugar cane consisting of:
 - o 60 acres of corn
 - 85 acres of cotton
 - o 1.5 acres of sugar cane
- 3 slaves:
 - Judah, a woman about 40 years old
 - Charles, Judah's child, about 7 years old
- Cows, hogs, horses, carts, wagons, beds, furniture, cloth, hats, shoes, spiritous liquors, and other articles of merchandize amounting to about \$2,000.
- All assets were valued at \$4,815.

John Fletcher agreed not to foreclose prior to 1 January, 1832. James G. Parks and family were allowed to remain in the house now occupied by them. James G. Parks and family were to be supported by the profits and income of the existing mortgaged property until 1 January, 1832 provided that James G. Parks did not exercise and control or management. James G. Parks signed his name. William Mizell witnessed. The deed was recorded 27 July, 1830. [Land Records of Houston County, GA, 1829-1831, Deed Book D, Volume 2, Campbell]

On 1 July, 1830, James G. Parks was named on a list of unclaimed letters remaining in the post office at Macon, Bibb County, GA. [Macon, GA Newspaper Clippings (Messenger), Volume 1, 1823-1830, Evans]

On 31 July, 1830, the following notice was published in the Macon Messenger:

- Georgia, Houston County: John Fletcher and Elizabeth Parks apply to me for letters of administration on the estate of James G. Parks, deceased.
- These are, therefore, to cite and admonish all and singular, the kindred and creditors of said deceased, to be and appear at my office within the time prescribed by law, to show cause, if any they have, why said letters shall not be granted. F. W. Jobson (signed)

On 6 September, 1830, in Houston County, GA, John Fletcher was granted permanent letter of administration on the estate of James G. Parks, deceased. William Mizell, John Young, Jacob Dunn,

Bryant Mangham, and Westly Williams were appointed as appraisers of the estate. [Wills & Inferior <u>Court Minutes of Houston County, GA, Volume 1, Henry</u>]

On 11 September, 1830, the following notice was published in the Macon Messenger:

 Georgia, Houston County: Will be sold before the court house door in said county on the first Tuesday in October, next, between the legal hours of sale, all property belonging to the estate of James G. Parks, late of said county, deceased. Sold for the benefit of the heirs and creditors of said estate. John Fletcher, administrator (signed)

On 7 March, 1831, in Houston County, GA, it was ordered that the estate of James G. Parks, deceased, be received and recorded. It was ordered that Sorvile Woolfolk, Lewis C. Allen, James Kivlin, Samuel K. Hodges, and Benjamin Tarver, all of Muscogee County, be appointed appraisers of the estate. [Wills & Inferior Court Minutes of Houston County, GA, Volume 1, Henry

On 7 November, 1831, in Houston County, GA, John Fletcher, administrator of the estate of James G. Parks, deceased, was granted permission to sell the lands and slaves of the estate after giving notice in a public gazette. [Wills & Inferior Court Minutes of Houston County, GA, Volume 1, Henry]

On 2 January, 1832, John Stapler filed suit against the estate of James G. Parks to recover money owed to him. [Wills & Inferior Court Minutes of Houston County, GA, Volume 1, Henry]

On 3 March, 1832, in Muscogee County, GA, property of James G. Parks was sold to satisfy a fi fa in favor of Isham Choat. The property sold by Wesley Williams was 2 slaves, Judy, age 45, and John, age 6. [Columbus, GA Newspaper Clippings (Columbus Enquirer), Volume 1, 1832-1834, Kilbourne]

On 15 December, 1832, the orphans of James G. Parks were named in a land lottery for Muscogee County, GA. [Columbus, GA Newspaper Clippings (Columbus Enquirer), Volume 1, 1832-1834, Kilbourne]

On 22 December, 1832, the heirs of James Parks, deceased, sold "one half of ten acres including the Islands and fish trap at the Island Ford of Yakin River" to Henry G. Hampton for \$25 (Surry County, NC Deed Book V, Page 54). The land had been conveyed from Salithiel Martin to Richard Cunningham and then from Richard Cunningham jointly to Thomas Hampton and James Parks. The land bordered Thomas Hampton, Richard Guinn, and John Shore(?). The heirs of James Parks were:

Enoch B. Hunt and James H___ witnessed the deed. The following note was made concerning the deed: "A deed was made by the heirs of James Parks, deceased, in October 12, 1829 since burnt in the house of H. G. Hampton ____ the 20th night on April, 1831 and was not recorded". Enoch B. Hunt proved the










ORIGINAL 15th DISTRICT LAND LOTS HOUSTON COUNTY, GEORGIA (Lost to Macon County in 1837)
