# Objective

# Identify the origin of Capt. Samuel Williams (1733 - 1788) of Washington County, TN and Greene County, TN.

Information on Samuel Williams received from Bonnie Tanner:

- Samuel Williams was part of the Watauga Settlement in Washington County, TN.
- Samuel Williams married Hannah Isbell, daughter of Zachariah Isbell, a neighbor.
- Zachariah Isbell was one of the original founders of Watauga and the state of TN.
- Samuel Williams served in the Revolutionary War along with John Sevier and Zachariah Isbell, Jr. He was at the Battle of King's Mountain and part of the Chickamauga Expedition.
- Samuel Williams was killed by Indians in 1788 in Greene County, TN along the Nolichucky River.
- Hannah Isbell Williams, widow of Samuel Williams, married James Taylor in 1792 in Greene County, TN.

- SC clues related to Samuel Williams neighbors in TN:
  - Cleavers Barksdale was from Abbeville, 96 District, SC. He was the son of John Barksdale whose will was date 1790. Note that Cleavers had a sister who married a Carter. Also, a witness to his father's will was James Allison. It's interesting that a John Allison was a witness to one of Samuel Williams 1785 deeds.
  - James Taylor is labeled in deeds as James Taylor of Camden, SC.
  - Surles Lewis was also from Camden district, SC (north east of 96 district).
  - Jesse Walton was from GA, no location given. But, note that Abbeville and the 96 District in SC border GA.
  - I found records of a James Ray (Wray/Rhea) in Abbeville, 96 District, SC. This is a common name, so may be a false lead.
  - I also found records of a Joseph Greer in Abbeville, 96 District, SC.
  - Note the 1785 Washington, TN deed from Samuel Williams to Jesse Walton of GA.
    Samuel was selling 384 acres of land, but an exception was made for Jacob Brown and his heirs. This typically implies a relationship. Or, perhaps Samuel Williams and Jacob Brown had somehow made the land entry as partners. Jospeh Greer and John Allison witnessed.
- Check early GA deeds in Putnam and Hancock counties.
- A family biography dated December, 1845 by Mary Briscoe Hillyer (b. 1811) of Eatonton, Putnam County, GA detailed the following information:
  - Mary Briscoe Hillyer's mother was named Chloe Williams, born 10 April, 1792 in Wake County, NC to Mabel and George Williams. As a child, her parents moved to Hancock County, GA, then to Putnam County, GA.
  - Chloe Williams married Basil Biscoe in February, 1811.
  - George Williams served in the "old revolution" in the American Army and lost part of his leg. He married Mabel Perry after the war. They had 8 children.
  - George Williams and his brother William Williams moved to Hancock County, GA, then to Putnam County, GA.
  - George Williams was living with his oldest son William Williams when he died in 1820 about age 60.
  - Mabel Perry Williams was the daughter of Francis Perry of Wake County, NC.

• George and Mabel Williams were the parents of: Priscilla, Rhuhannah, William, Francis, John, Chloe, Wilson, and Wiley.

### Project update July 11, 2021:

- Samuel Williams was positively identified in Surry County, NC! Zachariah Isbell, Jesse Bond, Charles Bond, and Jesse Walton were all confirmed as close Surry County, NC neighbors leaving no doubt that we have the correct Samuel Williams.

# **Final Conclusions**

Capt. Samuel Williams was living in Surry County, NC in 1774 and absorbed into Wilkes County, NC in 1777. He moved to Washington County, TN by 1778.

Capt. Samuel Williams was not the son of George Williams of Edgecombe County, NC.

Zachariah Isbell, Charles Bond, and Jesse Bond were in Surry County, NC by 1771. Jesse Walton was there by 1772. Samuel Williams was there by 1774. All of these men were close neighbors in Surry/Wilkes County, NC and Washington County, TN.


Samuel Williams was related to Jacob Brown and John Brown of Washington County, TN and Wilkes County, NC.

Charles Bond (Sr.) left a will in Surry County, NC in 1774 naming sons John Bond and Jesse Bond. Jesse Walton was an executor and witness and likely close kin to the family. It is proven that Charles Bond (Sr.) was from Albemarle County, VA.

# **Recommendations for Further Research**

The following counties in Virginia should be checked for surnames Bond, Brown, England, Walton and Williams:

- Albemarle County, VA
  - Charles Bond (Sr.) was here prior to moving to Surry County, NC in 1771.
- Bedford County, VA
  - Zachariah Isbell was here in 1754 according to research by Ray Isbell.
- Halifax County, VA
  - Zachariah Isbell was here from 1756-1758 according to research by Ray Isbell.
- Pittsylvania County, VA
  - Formed from Halifax County, VA in 1767.
- Lunenberg County, VA
  - $\circ$   $\;$  Bedford County, VA was formed from Lunenberg and Albemarle in 1753.
- Amherst County, VA
  - Formed from Albemarle County, VA in 1761.

An early Baltimore County, MD deed hints at a possible origin prior to VA for these families:

• 25 August, 1732

James Bond, cooper, of Kent County, MD sold 350 acres on Broad Creek to Thomas Renshaw, cooper, of Cecil County, MD. Joseph England and George Williams witnessed.

# Summary of Findings

### Samuel Williams of Edgecombe County, NC and Halifax County, NC:

In July, 1758, George Williams of Edgecombe County named his son Samuel Williams in his will. He gave him "land on Deep Creek which I purchased from William Whitehead".

In May, 1758, George Williams purchased 100 acres on the south side of Deep Creek from William Whitehead.

In November, 1774, Samuel Williams of Halifax County, NC sold 100 acres on the south side of Deep Creek to Lewis Brantely. The metes and bounds given in the deed were exactly the same as George Williams 1758 deed.

This proves that Samuel Williams, son of George Williams was still in Halifax County, NC in November, 1774.

### Samuel Williams of Surry County, NC and Wilkes County, NC:

In 1774, Samuel Williams was taxable with John Nail in Benjamin Cleveland's District in Surry County, NC. Being taxable in the same household typically indicates some type of kinship. The following were also taxable in the same district:

- Zacariah Isbell and Patrick Hockshau
- Jesse Bond and Mick Miller
- Charles Bond and John Bond
- Jesse Walton and Whitfield Wilson

Clearly, this was the same Samuel Williams who later entered land in Washington County, TN in 1778. Zachariah Isbell, Charles Bond, and Jesse Walton were all neighbors there.

Given that Samuel Williams was taxable in 1774 in Surry County, NC, he cannot be the same Samuel Williams who was still in Halifax County, NC in November, 1774.

In 1775, Samuel Williams was taxable in Benjamin Cleveland's District in Surry County, NC.

In 1777, Wilkes County, NC was created from Surry County, NC.

In April, 1778, a Wilkes County, NC land entry by John Brown mentioned adjoining landowners Humphrey Gibson and Samuel Williams. It is notable that Humphrey Gibson was also a neighbor of Samuel Williams on the 1774 Surry County, NC tax list.

The John Brown land entry was on Buffalo Creek in the NW corner of Wilkes County, NC near the border of TN. These families were living between the North Fork and the South Fork of the New River.

Given that Humphrey Gibson was a neighbor in 1774 and 1778, we can infer that Samuel Williams and his associates made their initial settlements between the forks of New River and were there as early as 1771.

In September, 1778, the Wilkes County, NC court ordered that Charles Roberson and James Stewart in Washington County, NC take depositions from Humphrey Gibson and Samuel Williams. They were being asked about John Brown's land entry as it was also being claimed by Ruth Batton/Barton/Boman.

The deposition order proves that Samuel Williams had moved to Washington County, NC.

### Samuel Williams of Washington County, NC:

In August, 1778, Samuel Williams entered 400 acres on the south side of Nolichucky River bordering Brown's Ford.

A January, 1779 land entry to Hosea Rose noted that he had obtained it from Capt. Samuel Williams.

In October, 1782, Samuel Williams was granted land on the south side of Nolichucky River bordering Charles Bond and Jesse Walton.

An October, 1782 grant to Jesse Walton mentioned neighbors Samuel Williams and John Woods.

In October, 1783, Samuel Williams made an entry in Greene County, TN on the south side of French Broad River. John Ward also claimed the land and Samuel Williams eventually transferred it to him. Was this John Wood?

In October, 1783, Zachariah Isbell entered land in Greene County, TN on the north side of Big Pigeon River.

In May, 1785, Jesse Walton of GA sold land on the south side of Nolichucky River to Joseph England of VA. The land bordered Charles Bond and Isham Randolph and had been patented by Samuel Williams. Jesse Bond was a witness.

The reference to Joseph England is an important clue because he was in VA in 1785 and a likely friend or relative of Jesse Walton. As shown in the next section of this report, Charles Bond was from Albemarle County, VA and Jesse Walton was his executor.

In May, 1785, Samuel Williams sold land on the south side of Nolichucky River to Jesse Walton of GA. This was one of Samuel Williams 1782 grants. An exception was made for Jacob Brown and his heirs. Samuel Williams signed his name.

The 1785 record implies that Samuel Williams was somehow related to Jacob Brown. Note that he had also been a neighbor of John Brown in Wilkes County, NC.

The presence of Charles Bond, Jesse Walton, Zachariah Isbell, and Jesse Bond confirm that these men moved from Wilkes County, NC to the Watauga Settlement in Washington County, NC.

### Charles Bond of Surry County, NC:

In March, 1774, Charles Bond of Surry County, NC wrote his will. He named sons John Bond and Jesse Bond. Jesse Walton was an executor and witness to his will. The will also named grandsons and left them land on Hardaway River in Albemarle County, VA.

The will of Charles Bond proves that the Bond family moved to Surry County, NC from Albemarle County, VA. It appears that Jesse Walton was kin to them.

### Samuel Williams (Sr.) of Rowan County, NC:

In 1761, Samuel Williams was taxable along with Joseph Williams, James Williams and Philip Williams. The name of his neighbors, including Aquilla Felps/Phelps, confirm that he was the same Samuel Williams taxable in 1768 in John Ford's district. He is designated in this report as Samuel Williams (Sr.) and he was born prior to 1739.

In November, 1785, Samuel Williams purchased land on Hunting Creek from Daniel Welson Easley. The land bordered Philip Williams, Charles Jolly, and the widow Roberts. James Williams signed as a witness.

The December, 1785, Charles Jolly sold land on Hunting Creek to John Felps. James Williams and Samuel Williams both signed as witnesses.

In February, 1786, Philip Williams sold land on the west side of Yadkin River adjacent "Aquilla Felps' Horse Ford Branch". Samuel Williams signed as a witness.

The records confirm that Samuel Williams (Sr.) could sign his name and was still living in Rowan County, NC in 1786.

### Samuel Williams, Jr. of Rowan County, NC:

In July, 1765, Vinson Williams sold land on the north side of Yadkin River to Samuel Williams. It was noted that the land formerly belonged to Edward Williams who had left it by will to his son, Vinson Williams. Jane Williams, widow of Edward Williams, was given rights to the land during her lifetime.

In June, 1772, Samuel Williams, Jr. sold the same land to John Garret. Samuel Williams, Jr. made his mark with an "S". Jane Williams had agreed to sell the land.

Samuel Williams, Jr. was probably the son of Vinson Williams.

### Facts on Capt. Samuel Williams of Washington County, TN and Greene County, TN:

### 25 August, 1778

**Samuel Williams** entered 400 acres in Washington County on the south side of Nolechuckey River bordering Brown's Ford. A warrant was issued 30 November, 1778. The land was surveyed 24 June, 1779.

[TN Land Entries, Washington County, 1778-1796, Pruitt]

### 7 January, 1779

Hosea Rose entered 320 acres in Washington County including "the plantation where Surles Lewis formerly lived". The entry had been made by Lewis who transferred to Jonathan Tipton who transferred to **Capt. Samuel Williams** who transferred to H. Rose. *[TN Land Entries, Washington County, 1778-1796, Pruitt]* 

### 25 January, 1779

James Ray (also spelled Wray and Rhea) entered 250 acres in Washington County on the south fork of Cherokee Creek joining **Samuel Williams'** entry and including the cabins called Custard's cabins on both of the creeks.

[TN Land Entries, Washington County, 1778-1796, Pruitt]

### 16 September, 1779

Clevures Barksdell, for Col. John Sevier, entered 640 acres in Washington County "on a cover joining **Samuel Wiilliams'** entry on the lower side". [<u>TN Land Entries, Washington County, 1778-1796</u>, Pruitt]

### 16 September, 1779

**Samuel Williams**, for Col. John Sevier, entered 640 acres in Washington County on the first cove below Camp Creek and near the head of Cove Creek. A warrant was issued 20 April, 1780, but the land was eventually surveyed for George Gordon in 1795. [TN Land Entries, Washington County, 1778-1796, Pruitt]

### 24 October, 1782

**Samuel Williams** was granted 384 acres on the south side of Nolachucky River by the state of NC (Washington County, TN Deed Book 1, page 287-288). The land was adjacent Charles Bound and Jesse Walton.

[Washington County, TN Deeds 1775-1800, Rae]

### 24 October, 1782

Jesse Walton was granted 432 acres on the south side of Nolechuckey River by the state of NC (Washington County, TN Deed Book 1, page 410-411). The land was adjacent **Samuel Williams** and John Woods. [Washington County, TN Deeds 1775-1800, Rae]

#### 22 October, 1783

**Samuel Williams** entered 400 acres in Greene County "on the south side of French Broad River about ¼ mile above the upper ford of the river". On 23 December, 1783, John Ward caveated the land. The court decided in favor of John Ward during the November term, 1784. **Samuel Williams** transferred the land to John Ward on 15 February, 1784. *[Land Warrants and Grants in Greene County, TN, 1783-1803, Pruitt]* 

### 4 May, 1784

Zachariah Isbell entered 100 acres in Greene County on the north side of Big Pigeon River joining 300 acres belonging to **Samuel Williams**. On 27 February, 1787, Zachariah Isbell sold the warrant to David Stuart.

[Land Warrants and Grants in Greene County, TN, 1783-1803, Pruitt]

### 7 June, 1784

**Samuel Williams** was issued a warrant for 300 acres in Greene County "beginning on the north side of Big Pigeon River below the war ford at the upper end of an island…running down the north side of Pigeon River". The land entry was made 29 October, 1783. 200 acres of the warrant went to Edward Seaborn and was granted 13 February, 1791.

#### November, 1784

Benjamin Tipton and Alex Rogers proved a bill of sale from **Samuel Williams** to John Ward. [Greene County, TN Minutes of the Court of Common Pleas, 1783-1795, Burgner]

### 2 May, 1785

Jesse Walton of GA sold 172 acres on the south side of the Nolachucky to Joseph England of VA (Washington County, TN Deed Book 2, Page 51). The land was adjacent Charles Bond and Isham Randolph. It had been patented by **Samuel Williams** 24 October, 1782. Jessee Walton signed his name. Jesse Bounds and Fran Bird witnessed.

[Washington County, TN Deeds 1775-1800, Rae]

### 2 May, 1785

Jesse Walton of GA sold 432 acres on the south side of the Nolachucky River to James Taylor of Camden District, SC (Washington County, TN Deed Book 3, Page 185). The land was adjacent **Samuel Williams** and John Woods. William Trimble witnessed.

[Washington County, TN Deeds 1775-1800, Rae]

### 2 May, 1785


**Samuel Williams** sold 384 acres on the south side of Nolachucky River to Jesse Walton of GA (Washington County, TN Deed Book 3, Page 194). An exception was made for "Jacob Brown and his heirs claiming from or under his heirs and assigns". **Samuel Williams** signed his name. Joseph Greer and John Alleson witnessed.

[Washington County, TN Deeds 1775-1800, Rae]

Signed Sealed and Delivered in presence of Joseph Greer & John Alleson Samuel Williams

#### 2 May, 1785

Jesse Walton of GA sold 200 acres on the south side of Nolachucky River to James Taylor of Camden District, SC (Washington County, TN Deed Book 3, Page 196). The land was adjacent **Samuel Williams**. It was formerly a grant made to **Samuel Williams** on 24 Ocotber, 1782 and had been sold by Williams to Walton. Vol. Sevier (*Valentine Sevier?*) and Nicholas Hale witnessed.



### Facts on Samuel Williams of Surry County, NC and Wilkes County, NC:

### 1771

"The petition of the inhabitants dwelling on the three Creeks of the Catawba River...Rowan County":

- "That your petitioners are living in the remotest part of this great and very extensive county, are so far distant from Salisbury, the seat of justice, the majority of us 100 miles or upwards...."
- "We therefore your petitioners being greatly increased in number sufficient as we conceive to support a county...grant that we may have a new county appointed us, on the upper part of the Catawba waters..."




"Researchers in the past have felt the reference in the petitions to the "Three Creeks" were to First Creek, Second Creek, and Third (John's River) Creek which flow into the Catawba, which would indicate the area around present-day Boone. The three creeks that form the South Fork of the New River were known as the Three Creeks by the early 1760s. My research on the New River has shown that by 1778 there was a well established road up the John's River to the Boone area. There are names on the 1771 petition that I have never been able to associate with any point on the Catawba River, only with the New River."







### 18 April, 1778

John Brown entered 200 acres (entry number 56) on the west side of Yadkin River at the mouth of Buffalow. The land bordered Humphrey Gibson and **Samuel Williams, Jr.** and included improvements made by Cornelius Boman. The land was caveated by Ruth Barton. [Land Entry Book, Wilkes County, NC, 1778-1781, Absher]

The original copy of land entry 56 was consulted. It reads as follows: "...200 acres lying in the county aforesaid on the north side of the Yakin River above the mouth of Buffalo beginning at the mouth of.... conditionally line between Humphrey Gibson and **Samuel Williams** including the improvement Ms. Cornelia Boman now lives...."


#### 30 December, 1778

The survey for John Brown's 1778 land entry (number 56) stated the land was on the north side of the Yadkin River beginning at the mouth of a dividing branch between him and James Deer and bordering the widow Barton's line. One of the corners was a "walnut tree on the side of the River near the mouth of Buffalow". Henry Hutson was Elias Wellborn were chain carries for the survey. 
#### 8 September, 1778

Map showing where Samuel Williams and his associates were between 1771 and 1774 https://www.carolana.com/Carolina/Settlement/nc\_rivers.html





Early map of Wilkes County showing two different streams named Buffalo Creek.






